Call to Order A guorum of the Board was present, and the Directors confirmed their

qualification to serve. The meeting was called to order at 5:36 p.m.

been filed with the Secretary of State.

### **Action Item:**

The Board reviewed a proposal and engagement letter from Lyons Gaddis for General Counsel services. A motion was made and seconded to approve the agreement as presented. The motion was approved by unanimous vote of Directors present.

Ron Fano thanked the Board, noted that he would work cooperatively with Mr. Chmil, and left the meeting.

Mr. Nikkel suggested that, since funds for legal services are allocated in the Meridian Service Metro District budget, that the MSMD board might consider ratifying the agreement. The Board discussed the matter, and Mr. Chmil noted that he would review the relevant Intergovernmental Agreement, discuss with Mr. Fano, and have a recommendation for the Board at their next meeting.

# **Visitor Comments**

Resident Sharon Pacheco commented on the quality of landscaping at the various entrances to the community. Mr. Nikkel discussed landscaping constraints at different locations, and the upcoming roadway construction at the Meridian & Rex entrance. Residents expressed concerns about rumors on various topics relating to the community, and Board members responded.
